# TO AUTHORIZE THE EXECUTION OF A CONTRACT MODIFICATION FOR FIRE ALARMS AND SECURITY SYSTEMS PREVENTIVE MAINTENANCE AND REPAIR SERVICES

WHEREAS, the District of Columbia Housing Authority (DCHA) requires necessary labor, materials, supplies, equipment and supervision for Fire Alarms and Security Systems Preventive Maintenance and Repair Services at DCHA properties to maintain uninterrupted services; and

WHEREAS, on December 13, 2017, the Board of Commissioners approved DCHA Resolution 17-29 to award a contract to John Xanthos, Inc. t/a C & A, Inc. to furnish all necessary labor, materials, supplies, equipment and supervision to provide Fire Alarms and Security Systems Preventive Maintenance and Repair Services at DCHA properties subject to the availability of funds; and

WHEREAS, the contract was executed on December 21, 2017 and was due to expire on December 21, 2020; and

WHEREAS, a Contract Modification was issued on December 8, 2020 and executed on December 23, 2020 that is due to expire on February 28, 2021; and

WHEREAS, COVID-19 has delayed PMO - Mechanical Operations ability to complete the necessary due diligence and procurement planning required to initiate a new solicitation for Fire Alarms and Security Systems Preventive Maintenance and Repair Services; and

WHEREAS, a Contract Modification is necessary to extend the term of the contract and add funding to maintain uninterrupted Fire Alarms and Security Systems Preventive Maintenance and Repair Services at DCHA Headquarters and Managed Properties to allow adequate time to complete a new solicitation and contract award.

WHEREAS, DCHA requests an extension to February 28, 2022 to provide additional time to complete the competitive procurement process for these services.
