# Ward 8 Plays Host to HCVP Basketball Tournament

DCHA Executive Director Adrianne Todman and HCVP Director Ron McCoy were joined by DC Mayor Vincent Gray and others who invested their final weekend in July to help DCHA's younger residents receive valuable life lessons.

The Mary Virginia Merrick Center in Southeast was the site for the First HCVP Youth Basketball Tournament. The two-day event, targeted for families participating in the voucher program, attracted more than one hundred youth ranging from ages 8 to 14.

The tournament was the first in a series for HCVP initiatives to enhance the lives of rent voucher recipients by engaging them in life affirming activities in the District.

In addition to the competitive games and spirited cheerleading, HCVP took the opportunity to educate the youth at the same time. When not on the court, there were workshops led by community leaders on skills needed for success, how to give back to the community and a host of other topics.

Mayor Gray gave the participants some sound advice, "I am very pleased to see that the DC Housing Authority has set up workshops in life skills that you can attend between games. Take advantage of these workshops; I believe the best thing that you can learn in life is how to make smart choices . . . both on and off the basketball court."

For this inaugural event, HCVP partnered with landlords and other District area businesses and agencies including Hope Findings, 100 Fathers, Honest Tea, IITF Technology, DC Department of Recreation, and the DC Arts and Humanities Council.

DCHA Executive Director Adrianne Todman said, "We're pleased with this great turnout and to see the enthusiasm of so many young people. Our team planned this event to help inspire youth to reach their full potential through education, positive sportsmanship, and team development. The goal is to develop good players and strong youth leaders."

# HCVP's New Direction

Ron McCoy has been a dedicated DCHA employee for more than 10 years. In August he was



in August he was introduced as the new Director for the Housing Choice Voucher Program, adding that to the many other positions he's held in that office.

DCHA Executive Director Adrianne Todman said she initially knew of Ron's work, but didn't know how well he'd work as director. After vetting him for more than a year, she confidently stated that he was knowledgeable, dependable and definitely the man for the job.

McCoy does have a wealth of experience from the many different positions he held within the program, including Compliance Manager, Financial Analyst, Interim Finance Manager, Leasing Manager and Deputy Director.

Since his arrival, McCoy has always had a vision for the program. He said he would like to look beyond just performing the core required functions of inspection, recertification, and leasing and providing rental subsidy to owners on behalf of our participating families.

"We must become active listeners to hear the real needs of our families to assist them with obtaining the services they need to survive and better their lives. We must also not overlook the needs of our partners—the property owners—who over the years have stuck with us through the ups and downs of the economy."

Since he stepped in as Interim Director more than a year ago, he has made several changes.

McCoy feels the best improvement for the program over the past year was the restructuring of the Inspections Department.

He believes the HCVP program has the potential to become a national model for success. He said, to achieve that goal the program needs to focus on customer service, accountability and improving communication using technology.

# Amended Recertification Policy for Elderly & Disabled Families

The District of Columbia Housing Authority is required to re-examine the income and composition of Housing Choice Voucher families at least every two years.

The Housing Authority is testing a modified policy to accommodate its single elderly and single disabled families to allow such families to complete their recertification by mail. In addition to mailing the information, your Recertification Specialist will be contacting you by the telephone number on record. If this number is incorrect, or has been changed please contact your Recertification Specialist at 202-525-1000 and update your telephone contact.

To be part of the mail-in recertification program, you must meet the following guidelines and provide needed information

- 1. You must be disabled or at least sixty-two years of age
- 2. The household composition must be comprised of either a single household member (elderly or disabled), or a disabled couple
- 3. You must be receiving a fixed income, such as Social Security and or Supplemental Security Income, Annuity Income or Veterans Benefits
- 5. You must mail a copy of all current income statements
- 6. You must provide all out-of-pocket expenses such as over-the-counter prescription bills and/or Medicare premiums
- 7. Your telephone numbers on record with DCHA must be current
- 8. DCHA must have a valid picture identification of you on file

Your application for continued occupancy and other requested information must be returned to your Recertification Specialist by the due date written in a letter you will receive from the HCVP Recertification Manager.

### **Attention Landlords and Owners:**

#### Remember the HCVP Rent Increase Policy

Landlords may only receive a rent increase in accordance with HCVP Policy which states that all rent increases shall be determined based on the LESSER of three criteria:

- The current contract rent multiplied by the applicable annual adjustment factor published by Housing and Urban Development (HUD) in effect; or
- The maximum approved submarket rent as most recently determined (or re-determined) by HCVP; or
- The amount requested by the landlord/owner
- •The owner may not have any inspection final fails in the last 12 months from the rent increase request and the family must reside in the unit for at least a year
- Project-based owners may request an increase annually for all units no more than 90 days from their contract month.
- •Rent increase requests must be submitted on the HCVP approved rent increase form, and must be submitted no later than 90 days from the family recertification month—which may differ from the contract effective date. Forms can be found on our website at www.dchousing.org

# HCVP Family Self Sufficiency Program Graduates 41 Participants

DC Councilmember Michael Brown, Chair of the Committee on Housing and Workforce Development, joined DCHA Commissioners Frank Lancaster and Bernadette Tolson, DCHA Executive Director Adrianne Todman and Housing Choice Voucher Program (HCVP) Director Ron McCoy as they honored the 2011 Family Self Sufficiency (FSS) program graduates.

This year's event was held at THEARC in Southeast Washington, DC. The FSS staff, along with Commissioners Lancaster and Tolson, started the program off with encouraging words and kudos to all the graduates; McCoy described this achievement as the "Epitome of success." DCHA understands that its job is not to enable its customers but to empower them. The FSS Program is designed to change the life of HCVP participants. The program is voluntary, but participants are required to sign a contract in order to participate.

Clients are required to declare their goals, which can range from improving credit and education, to getting a job and even homeownership. The average time for FSS program participation ranges from five to seven years. While in the program, a portion of their rent is saved into an escrow account which many graduates use toward a home purchase.

Out of the more than 40 graduates for this year, 11 achieved the goal of homeownership. The graduates were

given a chance to speak about the joys of being homeowners, and Mary Wren said, "When I first moved in, I didn't want people to touch my walls or have their shoes on my carpet."

Another graduate testified, "When I was young I remember cooking Thanksgiving dinner on a hotplate, we didn't have a stove. But now I am a homeowner!" This testimony put smiles on the faces of the FSS staff. Ronald Fisher, HCVP case worker, later explained how a bond is built between the case worker and the client, and the client's triumphs become the case worker's triumphs.

The guest speaker, Octavia Caldwell, is the owner and CEO of ROC Consultants, LLC. ROC Consultants provide entrepreneurial services to FSS participants. She entitled her speech "Don't Quit." Caldwell highlighted the life of former President Abraham Lincoln and his struggles on his road to success. The graduates nodded their heads because they, too, could relate to struggles and hardships. Caldwell closed her speech saying, "President Lincoln never gave up no matter how hard it got, and that's what I encourage you to do."
