

RESOLUTION 19-29

**TO AUTHORIZE THE EXECUTION OF A CONTRACT FOR UNIFORMS AND
PERSONAL PROTECTION EQUIPMENT**

WHEREAS, District of Columbia Housing Authority (“DCHA”) requires timely fulfillment of professional uniforms, personal protective equipment and related products and services for DCHA Employees;

WHEREAS, on December 13, 2018, Cintas Corporation was awarded the competitively solicited OMNIA Partners contract #R-BB-19002 under the Lead Public Agency of Prince William County Virginia Public Schools (the “OMNIA Partners Contract”) for a complete line of Facilities Maintenance Products;

WHEREAS, OMNIA Partners is the nation's most experienced cooperative purchasing organization serving state and local government that delivers cost savings for products and services and reduces the administrative costs associated with competitive bids for government agencies;

WHEREAS, DCHA is a Participating Public Agency of OMNIA Partners;

WHEREAS, DCHA orders uniforms, personal protection equipment and maintenance services for Property Maintenance Operations (PMO) employees;

WHEREAS, DCHA determined that Cintas Corporation is a qualified firm capable of providing the required uniform and personal protection equipment and related maintenance services;

WHEREAS, Cintas will provide First Aid/CPR trainings that will be held at DCHA's Southwest Family Enhancement Center at least three times per year as an economic opportunity for our clients as a Section 3 commitment; and

WHEREAS, DCHA performed a review of the Federal Systems Award Management on September 5, 2019 and has determined that Cintas Corporation does not appear on that list.


