

## **RESOLUTION 19-30**

### **TO AUTHORIZE THE EXECUTIVE DIRECTOR TO EXECUTE A CONTRACT MODIFICATION FOR PEST CONTROL SERVICES AUTHORITY-WIDE**

WHEREAS, District of Columbia Housing Authority ("DCHA") requires qualified professional Authority-Wide Pest Control Services to eradicate the infestation of pests and to maintain a safe and healthy environment for DCHA residents;

WHEREAS, on February 10, 2016, the Board of Commissioners adopted Resolution No. 16-01 approving a contract for pest control services Authority-wide with Pest Services Company, Inc.;

WHEREAS, DCHA entered into a contract with Pest Services Company, Inc. on March 3, 2016, to provide all necessary labor, materials, supplies, equipment and supervision for comprehensive pest control services authority-wide in order to eradicate the infestation of pests and to maintain a safe and healthy environment for DCHA residents;

WHEREAS, a contract modification is necessary to continue the services of the existing company during the competitive procurement process and award;

WHEREAS, these critically important services have exhausted the contract authority approved by the Board of Commissioners and the contract terms have expired;

WHEREAS, DCHA performed a review of the Federal Systems Award Management and the District's Excluded Parties List on August 23, 2019, and has determined that Pest Services Company, Inc. does not appear on that list.




