

RESOLUTION 19-19

TO AUTHORIZE THE EXECUTIVE DIRECTOR TO EXECUTE A CONTRACT FOR ARCHITECTURAL/ENGINEERING SERVICES

WHEREAS, District of Columbia Housing Authority ("DCHA") requires architectural engineering services for the Montana 5-RAD Conversion Project;

WHEREAS, on June 3, 2018, DCHA advertised a Request for Proposals ("RFP") in *The Washington Post*, *Afro American*, *The Current Newspaper*, *The Washington Informer*, *Hill Rag*, *El Tiempo Latino* and *East of the River*. Copies were emailed to all District Government Certified Business Entity members and all District of Columbia Department of Housing and Community Development ("DHCD") Section 3 vendors;

WHEREAS, on June 4, 2018, Solicitation No. 0021-2018 Professional Architecture Engineering Services was issued to the Department of Small and Local Business Development, bidders interested in doing business with DCHA, posted to the DCHA Website and issued directly to six (6) firms;

WHEREAS, July 6, 2018, DCHA received twelve (12) proposals for evaluation;

WHEREAS, the solicitation stated that DCHA intended to award multiple awards to firms deemed technically qualified and establish a Qualified Bidders Listing (QBL) for further consideration of award in accordance with the solicitation requirements for professional architecture engineering services and in the best interest of DCHA;

WHEREAS, the scope for the Montana 5-RAD Conversion Project was sent to the Agency Architectural and Engineering QBL firms for proposals;

WHEREAS, based on the proposal, best and final offers and the results of the evaluation process, DCHA determined that Amar Group LLC has met the technical requirements and price reasonableness for Architectural Engineering Services for the Montana 5- RAD Conversion Project; and

WHEREAS, DCHA performed a review of the Federal Systems Award Management and the District's Excluded Parties List on June 27, 2019, and has determined that Amar Group LLC does not appear on that list.
