Chairman Thompson called the meeting to order on Wednesday, February 8, 2017 at approximately 11:08 am.

The minutes of December 14, 2016 were considered and accepted.

Chairman Thompson announced that a quorum was present and requested a motion to close portions of the meeting related Personnel matters<sup>1</sup> as outlined in today's meeting agenda, which includes personnel matters pursuant to D.C. Code § 2-575(b)(10). A majority vote was taken to close the foregoing portions of the meeting. After discussion of the closed matters, the meeting was re-opened by the Chairman.

The Office of Capital Programs provided the Board with an updated real estate/business deals template based on feedback received in the prior week's Committee on Development and Modernization meeting. There was discussion regarding New Communities and how DCHA partnered with developers and has generated the framework or test of some of the scenarios outlined in the template. Commissioner Slover stated that he appreciated the additions and added that his vision would be to start off with scenario *A* and would like a detailed

explanation when certain scenarios occur. It was stated that the test development would be Lincoln/Heights Richardson.

An overview of resolution 17-01 was provided by Operations Stating that the pet policy would bring DCHA into compliance for senior and disabled sites and that the policy must allow for common household pets. The policy was available for public comment for 30 days. There was discussion in the Committee on Operations meeting earlier today regarding existing pets and the amendments have been made to the policy. There were also three changes made during the comment period including the change in weight and height increase limits for dogs, tank size increase for aquariums and changed the pet deposit to refundable which is expected to be set at \$50. Most comments were from people outside of DC and there was just one comment from a resident. There was discussion regarding violation of the pet policy and if it could lead to an eviction. It was stated that it is a curable violation and DCHA would give residents an opportunity to correct without getting evicted. Director Todman expressed the urgency in adopting the policy. The new language amends the policy to allow for anyone with an existing pet today to keep it. The policy reflects the wishes of the residents and the issues of implementation will be further discussed. Commissioner Mobley asked if the noise factor of some pets was considered. It was stated that it was. Commissioner Council stated that he wanted to be more comfortable with the policy. There was discussion regarding implementation and the safety and liability of residents. Commissioner Lancaster stated that residents who own pets should be encouraged to get renters insurance.
