## **RESOLUTION 10-41**

TO APPROVE AND ASSIGN A MEMORANDUM OF UNDERSTANDING BETWEEN THE DISTRICT OF COLUMBIA HOUSING AUTHORITY AND THE DISTRICT OF COLUMBIA DEPARTMENT OF CONSUMER AND REGULATORY AFFAIRS FOR THE PURPOSES OF INSPECTING, CITING AND ABATING EXTERIOR HOUSING CODE VIOLATIONS

WHEREAS, the District of Columbia Department of Consumer and Regulatory Affairs (DCRA), which is responsible for compliance with the District of Columbia Housing Code, has requested the services of the District of Columbia Housing Authority (DCHA) for the purposes of identifying, citing and abating exterior housing violations at properties identified by DCRA throughout the District of Columbia; and

WHEREAS, DCHA and DCRA have negotiated a Memorandum of Understanding outlining the roles and responsibilities of both parties and the scope of services, including the removal of abandoned vehicles as well as addressing life or health threatening emergency situations within 72 hours; and

WHEREAS, DCRA has budget \$300,000 and has agreed to pay DCHA for all services rendered, including allowable administrative cost for reasonable overhead, which will be calculated as a percentage of the actual cost of services for each property, under the terms and conditions of the MOU; and

WHEREAS, DCHA also wishes to assign the Amendment to DC Housing Enterprises (DCHE).

NOW THERFORE, BE IT RESOLVED, that the Board of Commissioner hereby authorizes the Interim Executive Director to 1) enter into a Memorandum of Understanding between the District of Columbia Housing Authority and the District of Columbia Department of Consumer and Regulatory Affairs in an amount not to exceed \$300,000.00 for the purposes of DCHA identifying, citing and abating exterior housing violations to include life and health threatening emergencies at properties identified by DCRA. 2) The assignment of said Memorandum of Understanding to DC Housing Enterprises.
