

RESOLUTION 19-02

TO AUTHORIZE THE EXECUTION OF LEGAL SERVICES CONTRACTS

WHEREAS, District of Columbia Housing Authority ("DCHA") has a need to obtain legal services authority-wide;

WHEREAS, on September 30, 2018, DCHA advertised a Request for Proposals ("RFP") in *The Washington Post*, *Afro American*, *The Current Newspaper*, *The Washington Informer*, *Hill Rag*, *El Tiempo Latino* and *East of the River*. Copies were emailed to all District Government Certified Business Entity members and all District of Columbia Department of Housing and Community Development ("DHCD") Section 3 vendors;

WHEREAS, on October 1, 2018, Solicitation No. 0041-2018 General Legal Services was issued to the list serve members of the Department of Small and Local Business Development, District Housing and Community Development (DHCD) Section 3 vendors. The solicitation was issued to all bidders interested in doing business with DCHA and issued directly to five (5) law firms;

WHEREAS, by November 14, 2018, DCHA received nine (9) proposals for evaluation;

WHEREAS, the Solicitation stated that award will be made to multiple Respondents with proposals determined to be qualified in accordance with the Solicitation requirements for several types of legal services and in the best interest of DCHA;

WHEREAS, based on the evaluation criteria, it was determined that seven (7) were qualified for contract recommendation for contracts with a value of over \$250,000;

WHEREAS, a review of the System Award Management dated February 5, 2019, as published by the U.S. General Services Administration has been conducted and the Respondents do not appear on the list;


