TO AUTHORIZE THE SUBMISSION OF AN APPLICATION TO HUD FOR THE DEMOLITION AND/OR DISPOSITION OF PUBLIC HOUSING UNITS AT LINCOLN HEIGHTS

WHEREAS, in 2005 the District of Columbia (the "District") Council named Lincoln Heights a New Communities Initiative site;

WHEREAS, in 2005 the District Government, District of Columbia Housing Authority ("DCHA"), and the residents of Lincoln Heights community ("Lincoln Heights") convened to develop a plan for the revitalization of Lincoln Heights and the surrounding Deanwood neighborhood;

WHEREAS, that process produced the *Lincoln Heights & Richardson Dwellings New Communities Initiative Revitalization Plan* (the "Revitalization Plan"), which the Council of the District adopted in late 2006;

WHEREAS, the Revitalization Plan envisions the transformation of Lincoln Heights and the surrounding neighborhood into a mixed-income, mixed-use community, where public housing residents and new community residents would have access to a variety of high quality affordable housing options - including one-for-one replacement of public housing units (on the Lincoln Heights footprint or elsewhere in the Deanwood neighborhood), "work force" housing, and market rate units for purchase or rental;

WHEREAS, DCHA is refining its plans for the phased redevelopment of Lincoln Heights, including new resident consultations and new development phasing and financing plans;

WHEREAS, to facilitate this redevelopment, pursuant to Board of Commissioners Resolution 13-28, DCHA submitted to HUD an application for authority to demolish and/or dispose of the entire 440-unit Lincoln Heights site;

WHEREAS, By letter dated August 19, 2015, HUD agreed to table consideration of that application, and, in the interim, to consider DCHA's amended application to demolish walk-up buildings (407, 411 and 413 50th Street, NE; and 5015 Fitch Place, NE) and townhouse dwellings (5017-5027 Fitch Place, NE) at DCHA's Lincoln Heights Development ("Lincoln Heights"), comprising thirty-three (33) public housing units (the "Demo Units"), the continued presence of which poses public safety issues;

WHEREAS, DCHA proposes to apply to HUD for the authority to demolish the Demo Units; and

WHEREAS, the Demo Units are obsolete, vacant and post a public safety issue under applicable HUD regulations, justifying the proposed demolition.
