# **RESOLUTION 19-27**

#### To Approve the District of Columbia Housing Authority Operating Budget for Fiscal Year 2020

#### <u>Summary</u>

In accordance with the regulations of the United States Department of Housing and Urban Development (HUD), prior to the beginning of its fiscal year, public housing authorities are required to prepare an operating budget in a manner prescribed by HUD. The public housing authority's Board of Commissioners must review and approve the budget by resolution. Each fiscal year, the public housing authority must submit to HUD, in a time and manner prescribed by HUD, the approved Board Resolution.

### TO APPROVE THE DISTRICT OF COLUMBIA HOUSING AUTHORITY OPERATING BUDGET FOR FISCAL YEAR 2020

WHEREAS, in accordance with the applicable regulations promulgated by the United States Department of Housing and Urban Development (HUD), the District of Columbia Housing Authority (DCHA) is required to approve the agency's Operating Budget prior to the beginning of the fiscal year; and

WHEREAS, a proposed Operating Budget for Fiscal Year 2020 in the amount of \$540,281,146 has been presented to the Board of Commissioners for its review (including the Asset Management Projects) and approval;

NOW THEREFORE, BE IT RESOLVED, that the Board of Commissioners of the District of Columbia Housing Authority hereby approves the Operating Budget for Fiscal Year 2020 (a copy of which is attached hereto), and authorizes the submission of this Resolution to HUD.
