APPROVING THE APPOINTMENT OF ADRIANNE TODMAN AS EXECUTIVE DIRECTOR OF THE DISTRICT OF COLUMBIA HOUSING AUTHORITY

WHEREAS, the Board of Commissioners of the District of Columbia Housing Authority (DCHA) is authorized by D.C. Official Code § 2-213 (a) to appoint and employ an Executive Director ; and

WHEREAS the Board recognizes the critical need to appoint an Executive Director to manage the day-to-day operations of the DCHA; and

WHEREAS, the entire Board, acting as a search committee, conducted an extensive search for candidates for the position with the assistance of an executive search firm experienced in identifying candidates for Public Housing Authority senior management; and

WHEREAS, the search firm met with the Board and DCHA stakeholders including but not limited to residents, resident leadership, DCHA employees, advocates for DCHA residents and participants, public officials, etc. to gain insight for a job profile; and

WHEREAS, the Board and the search firm developed a job profile and evaluation criteria for selecting qualified candidates; and

WHEREAS, the Board and search firm made a public announcement of the search and solicited applications; and

WHEREAS, the search firm received 138 applications and evaluated them based on the evaluation criteria; and

WHEREAS, the search firm presented the top 15 candidates' blind profile to the Board from which the Board selected 6 candidates for interviews ; and

WHEREAS, the Board, after conducting the interviews, has concluded the best candidate for appointment as Executive Director is Adrienne Todman; and


Approving The Appointment Of

WHEREAS, the Board having concluded employment contract negotiations with Ms Todman desires to appoint her as Executive Director upon the following principal terms; an annual salary of \$215,000 with the following benefits; health and life insurance, potential bonus for performance, pension, and sick and annual leave, for a term of three (3) years,

NOW THEREFORE, BE IT RESOLVED, the Board of Commissioners of the DCHA hereby appoints Adrienne Todman to be the Executive Director of the District of Columbia Housing Authority effective December 8th, 2010; and authorizes the Chairman to execute the employment contract containing the principal terms described in this resolution as presented to the Board of Commissioners on December 8, 2010.
